TOWN COUNCIL MINUTES

1. CALL TO ORDER

Mayor Henry called the meeting to order at 5:00 PM.

2. PUBLIC COMMENTS

- a. No public comments

3. BUSINESS

A. Pawleys Creek Debris Removal – Action Item

- I. Mayor Henry stated that there were dock structures in the navigable waterways that the Town is concerned about. Mayor Henry stated that of four companies that were contacted about the debris removal, C-WAY was the only company to come back with a bid for the work. Daniel Newquist stated that the four contractors were Cape Romain, Ellerbe site work, Blackwater dredging and recovery, and C-WAY. Mayor Henry mentioned that C-Way provided the Town with three separate quotes that address different sections of the creek. Daniel Newquist confirmed that the total cost to cover the entire work will be \$17,000. Daniel Newquist explained that he asked C-Way to provide separate quotes depending on the location of the debris. Daniel Newquist mentioned that he did this based on guidance from FEMA on their reimbursement policy. Daniel Newquist noted that in addition to this, there would need to be memorandums of agreement with the County and the State of South Carolina, due to the location of the debris. Daniel Newquist stated that if the conditions are followed the Town would be eligible for up to 75% reimbursement. Mayor Henry stated that since the Town has followed the appropriate steps for reimbursement and has the required permission, the Town Council will need to vote on and approve the \$17,000 for the work to be done. Mayor Henry asked if they would be able to start work as soon as possible. Daniel Newquist stated that he has been in contact with C-WAY, and they already have equipment in the creek working in other areas. Daniel Newquist stated that he hopes to have it completed by next week and he expects the work to be completed in four (4) days. **Mayor Henry asked for a motion. Rocky Holliday motioned to approve the expenditure of \$17,000 for**

removing the creek debris. Ashley Carter seconded the motion. No further discussion. All voted in favor.

4. COMMENTS BY COUNCIL MEMBERS

- a. Rocky Holliday thanked everyone for their work on the Hurricane recovery and commended staff for their speedy efforts to get things moved along in a professional and timely manner.
- b. Ashley Carter stated that he was having some problems with his boardwalk and replacing it but that is a personal issue.
- c. Mayor Henry thanked everyone for coming to get the debris out of the creek.

5. ADJOURNMENT

Mayor Henry asked for a motion for adjournment. Rocky Holliday started a motion to adjourn the meeting. Ashley Carter seconded the motion. All voted in favor.
