The Town of Pawleys Island is soliciting bids to repair Hurricane Ian damages sustained on the beach. The project work area will be from the Third Street Beach access (33'26'19.61N 79'06'54.10W) to approximately 530 Myrtle Ave (33'25'02.34N 79'07'41.54W) The following is a list of specific work tasks needed to return the beach dune system to its pre-storm condition:

- Installation of approximately 8,500 linear feet of sand fencing utilizing the chevron installation pattern per SCDHEC OCRM regulations to protect nesting sea turtles.
- Planting a mixture of dune vegetation species including bitter panicum, sea oats, and American beachgrass. Approximately 85,000 individual plants are needed to establish consistent and adequate coverage across the project area described above.

The proposal must include the following:

The contract shall be awarded based on the following criteria:

- Bid price.
- The ability, capacity, and skill of the bidder to perform the contract or to provide the services required.
- Whether the bidder can perform the contract or provide the services promptly, or within the time specified without delay or interference.
- The character, integrity, reputation, judgment, experience, and efficiency of the bidder.
- The quality of performance of previous contracts or services.
- The previous and existing compliance by the bidder with laws and ordinances relating to the contract or services. Understanding of and ability to comply with the SCDHEC-OCRM General Permit GP-90-F: Sand Fences, minor beach renourishment, dune vegetation, and adhere to mitigation requirements during sea turtle nesting season- May through October.

- The sufficiency of the financial resources and ability of the bidder to perform the contract or provide the service.
- The quality, availability, and adaptability of the supplies or contractual services to the particular use required.
- The ability of the bidder to provide future maintenance and service for the use of the subject of the contract.
- The number and scope of conditions attached to the bid.
